

s second semester got underway at Malibu High School, The Current conducted an anonymous poll of the 10th, 11th, and 12th grade student body regarding the effectiveness of our school's sexual education. Here at Malibu High School, sex ed is taught over about two to three weeks in freshman seminar, and we sought to investigate how students felt about their sexual education. The poll questioned students on topics such as the extent of their preparedness following sex ed, whether they felt safe discussing their sexuality on campus, whether they felt they had an adequate degree of knowledge, and whether sex ed should be improved. The poll examined these results according to grade level, gender, sexual orientation, and sexual activity.

The poll resulted in significant differences in opinion based on these demographics, as well as many general conclusions. For one, the vast majority of students do in fact feel safe to talk about sexuality on campus, with 90 percent of males and 88 percent of females agreeing amongst all grades. The majority of LGBT+ students also feel safe, with 70 percent in agreement. While the lesser percentage of positive responses among LGBT+ students demands room for improvement, the overall result suggests the relative effectiveness of Malibu High School's sexual education and showcases that Malibu High tends to have a positive and accepting attitude toward sexuality.

One of the most interesting conclusions of the poll is

the disparity in opinion between students who are sexually active and those who are not. In general, sexually active students feel far more strongly that sex ed is inadequate, while most non-active students are of the opposite sentiment. The likely reason for this result is that students who become sexually active might realize that there is more to learn than what meets the eye, clearly suggesting a need for improvement.

On the topic of improvement itself, most students feel that sexual education must be improved (only junior males felt otherwise). Females were also more likely than males to desire improvement, with 78 percent of females agreeing and 60 percent of males agreeing. However, the fact that both males and females across all grades predominantly desire a change in sexual education again showcases the need for improvement.

The poll also asked students what they thought could be improved with Malibu's sex education. Obviously there is no singular answer to this question, but a few common solutions have arisen out of this need for improvement. Considering the fact that members of the LGBT+ community often feel more unsafe than others, many students desire greater inclusion of these communities in sex ed curriculum. We received multiple comments on the polls expressing that there was not enough taught about homosexual sex. Other common responses included a greater emphasis on the technical aspect of sex itself, as undesirable as it may be for teachers to explain. Students also predominantly desired a de-emphasis on abstinence, with a greater

focus on safe sex practices. Multiple seniors suggested in their comments there should be a "refresher" course on sex education taught later in high school, as the time most students become sexually active is later in high school, and by this time much of the information they learned freshman year has been forgotten. There were also multiple comments across all grades asking for a greater emphasis on consent and that rape culture should be addressed more fully in the course, as they did not feel like people left the class with an understanding of consent.

With all data compiled, it is the opinion of the editorial board of *The Current* that while sex ed at Malibu High is effective, there is room for improvement in order to reach its full potential and be inclusive of the student body. Although changes cannot occur unless the state of California changes its curriculum, we hope future changes will include a greater emphasis on LGBT+ students, de-emphasis on abstinence, and education on actual sexual practices. Freshman seminar teachers here at MHS can make additional efforts to include these topics for the time being as well. We commend and appreciate the work of the Westside Family Health Center for providing free and confidential sexual health services on our campus. They will be on campus March 2 and May 4 this semester. Ultimately, it is our hope that Malibu High can create a healthy sexual atmosphere where everyone is educated, informed, and in-

# Rain in SoCal

ain is something special in California. As we are beginning our sixth year of the driest period to ever occur in California, most of Califoria is out of the drought. A very rainy winter has alleviated the drought in Northern California, leavig Southern Calirfornia merely "dry" or in "moderate drought." 102 million trees have died because of the drought, 62 million in 2016 alone. Governor Jerry Brown installed statewide restrictions for water use up to 25 percent in urban areas. The cost of water for farmers is over ten times higher than it used to be, meaning many farmers might go out of business. With climate change also factoring in, as well as multiple spills resulting in fresh water getting lost into the

Student Jason Leow said, "I go on Boy Scout outings very often. We go to Lake Cachuma up by Santa Barbara, that's the reservoir for the whole Santa Barbara county, and it's a tenth of the size that it used to be. There used to be islands there but now there aren't. The water is just so low, you can't fish there, you can't do anything there anymore. It's really sad." Jason said people can help by reducing the amount of water they use on watering their lawns and washing their cars. "You really don't need to do that as much. Invest in gardens that run on native succulents. Rock gardens or cactus gardens, things that don't require a lot of watering."

Senior Sienna Aiello said: "Since school started... it seems to rain a lot more than it used to in the last several months." Nevertheless, people should still "take shorter showers. Turn the faucet off when you're brushing your teeth. Don't get water at restaurants if you're not going to drink

Looking to the future, California should look to other countries that have suffered droughts in the past. Reporters from NBC travelled to Israel to find out more about the reason that, after experiencing the worst drought in 900 years, Israel now produces more water than necessary. "The country adopted advanced water recycling, emphasized efficient irrigation techniques that had first been invented 50 years ago, encouraged rain catchment systems at schools and on buildings, and aggressively began building and installing desalination plants," wrote NBC's reporters.

xtremely rare sightings of black bears found south of the 101 freeway in the recent months have wildlife conservationists excited about what the future holds for bear populations in southern California.

On August 4, the National Park Service caught video surveillance of a black bear wandering around Malibu Creek State Park. The image was captured on July 24 but was not seen until the later date. Bears have not populated and lived in the area since the 19th century but there have been pockets of bear populations living in the San Gabriel and Santa Susana mountains. However, sightings remain rare.

In 2014, a bear was killed after being run over by a car on the 101. This event marked the increasing amount of bear sightings in the area. Joanne Moriarty, a National Park Ranger, in an interview with KTLA said that it's "definitely a good thing" that bears are repopulating themselves around the area.

On June 10, the same bear found in Malibu Creek State Park was spotted near the Zuma/Trancas area about 2 miles from the coast in Malibu resident, Benton Ward's, backyard. The Park Service doesn't know any specifics about the bear but are continuing to try to gather information.

Kate Kuykendall, who works for the National Park Service said in an interview with NBC News with regards to the newly acquired animal resident of Malibu that "whether it actually physically crossed the 101 Freeway, or whether it found some kind of underpass or other way to get to the other side, we're not sure."

Bears used to live in plentiful


numbers in the greater Los Angeles area. However, with the influx of settlers to the California coast in the 1800s, their population dwindled. Specifically, the California grizzly bear was seen by many settlers as a threat that needed to be disposed of. Throughout the following century bears were hunted for not only their meat and fur, but also in hopes of driving off the population indefinitely. However, as the general public began to realize the crime committed by killing off thousands of bears, the native Yosemite black bear was introduced to southern California with hopes of reviving the bear population that once was.

Bears sightings have increased in other areas of Southern California as well. A bear cub was caught climbing a concrete slab in Duarte, California on April 24. Then again in early June, a bear was caught swimming in a pool in La Canada, Flintridge. Andrew Hughan, of the California Department of Fish and Wildlife said in an article with the Daily News said, "We should probably expect several more of these." Some expect that areas such as Duarte will be the epicenter for bear population growth.

Many have credited California's severe drought with the recent bear sightings. With little water to drink, the bear population is looking to expand their territory in order to find prey.

Paige Barrett, junior, was intrigued by the reintroduction of bears saying, "maybe one day I'll see a bear in my backyard."

The future of bears in Malibu remains unknown but the recent sightings look promising for population increase within the greater Los Angeles area.

n Nov 25, the world observed the death of the Cuban Communist leader Fidel Castro in his homeland of Cuba. Controversial in his methods of politics, Castro has warranted the attention of many governments and politicians as one of the few communist leaders still living into the twenty first century.

Fidel Castro was born near Biran, Cuba on August 13, 1926. Upon graduating from his high school El Coligio de Belen, Castro entered law school at the University of Havana and entered a climate of Cuban nationalism, anti-imperialism, and socialism, getting him involved in the world of politics. In 1947, Castro participated in a coup to overthrow the Cuban dictator Rafael Trujillo, which failed, but Castro still participated actively in antigovernment riots and sought to expose the General Fulgencio Bastida. Castro continued to play

a role in Cuba's politics, as well as marrying Mirta Diaz Balart from a wealthy political family, and in 1949 they had their only Castro began to take an interest in the teachings of Karl Marx and planned to run for a seat on the Cuban congress, but a 1952 coup by General Bastida overthrew the government and left Castro without a legitimate platform or means of supporting his family. Bastida declared himself dictator, and, in response, Castro led an insurrection on the Moncada military barracks, but the attack failed and Castro, his brother Raul, and several other insurgents were captured and jailed. Freed by an amnesty deal in 1955, Castro fled to Mexico with Raul to plan a revolution, meeting Che Guevera who helped to shape Castro's political beliefs. Castro returned to Cuba in 1956 with over 80 soldiers and some weapons, but most insurgents were captured by Bastida's forces while Castro, Raul, and Guevara fled to the mountains

with what few remaining forces they had. For the next two years, Castro led a campaign of guerrilla warfare against Bastida, and by child Fidel. It was at this time that 1958, Castro held a large amount of territory in Cuba, had a great amount of public support, and had won several victories over Bastida's troops. In 1959, Bastida fled to the Dominican Republic, allowing a provincial government to form under which Castro was sworn in as prime minister within one month, while hundreds of members of Bastida's government were tried and executed.

As the new leader of Cuba, Castro implemented communist reforms that created tension between American companies and Cuba, evolving into tension between the two governments. In January 1961, President Eisenhower broke off diplomatic relations with Cuba, and by April, Castro formally declared Cuba a socialist state. Three days after the socialist declaration, over 1400 Cuban exiles invaded the Bay of Pigs with support from the

US, but were quickly stopped by Castro's forces, who killed hundreds and captured over 1000. The rising tensions between the US and Cuba climaxed to a point when Castro ended democratic elections in Cuba, denounced American imperialism, and announced that Cuba was adopting communist economic and political policies, to which the US responded with a full economic embargo in 1962. Castro continued to be a thorn in the side of the US as an ally to the USSR that was uncomfortably close to the US.

The Cuban missile crisis occurred under Castro's regime, and served to only prolong US and Cuban tensions. With the collapse of the Soviet Union with its negative impact on the economy of Cuba, Castro began to limit some government restrictions slowly, until he retired due to health issues in 2008 and left command of the country to his brother Raul.

arly January, the price of gas in Mexico rose by 20%, appalling and infuriating the majority of the Mexican people.

This raise in gas price was part of the "Acuerdo para el Fortalecimiento Económico y la Protección de la Economía Familiar" as named by President Peña Nieto, while the general public has named this gas raise "gasolinazo." Mexico's poverty level is almost 50% of its entire population, this raise in gas prices causing a major change in their lives.

President Peña Nieto has stated that the raise in gas price is part of the Acuerdo, which translates to agreement. Peña Nieto and his administration have come up with this Acuerdo and claim that the raise in gas prices will keep the price of food, as well as other necessities, lower. Mexico has been experiencing inflation for the past few years, and the value of the peso, Mexico's currency, reached an all time low at 20 pesos to the dollar at the end of 2016, and experienced a drop to 22 pesos equating 1 dollar in the beginning of 2017. Peña Nieto stated that another reason for the change was for the price of gasoline to reach international levels, as the price of petroleum also rises. Reportedly, Mexico has been producing less gasoline than it used to, hurting the economy and calling for a raise in gas prices.

The people of Mexico are greatly affected by the spike in gas prices as many of them are unable to afford the new price of the gallon. The new gas price is intolerable as the minimum wage in Mexico is 80 pesos per day in the main districts, which is equivalent to about 3 dollars and 50 cents. A Mexican citizen said that 80 pesos is "not enough for a family of four" and opinionated that, "the raise is bad, as the people have a low income." The source also said that, "if they raise the price of gasoline, they should also raise the minimum wage." While raising minimum wage would be a great help to Mexico as a whole, minimum wage was already increased this year to 80 pesos, as it used to be 70 pesos a day in 2015. Yet with the inflation that has occurred in the past few years, the increase has not had the impact it should have.

PEMEX, the Mexican national gas company,

allows the Mexican government to control the price of gasoline. Therefore the people recognized their government to be responsible for the price raise, and people took to protesting. Hundreds of Mexican citizens protested in the streets, including in the capital. These protests expanded to 28 of the 32 states of Mexico, displaying the magnitude the change holds. The people protesting demanded for President Peña Nieto to resign from office, which had also been a major theme in protest on Mexico's Independence Day. In these protests many held signs with many variations of "Fuera Peña" and "No Al Gasolinazo."

Along with these protests, stealing from markets and gas stations were another reaction. As people realized they would not be able to buy gasoline, or that they would not be able to buy other necessities with the raise in gas prices, they stole food and other items. The day the price was raised, many people were at gas stations stealing and saving gas in groups. Entire families went to markets and filled their hands with anything they could carry: toys for the kids, household items, and of course, food. The police were assisting to stop these riots, and eventually the military began to pile through the markets and line the streets to contain the riots as they began to spiral out of hand. Nethertheless, four policeman we fired after they were caught stealing as well. These riots led to over 700 arrests on the first day, as people were continually jailed to stop the commotion. The people who weren't involved in the riots were forced to stay inside, afraid of the violence in their neighborhoods. This raised many questions as to how President Peña Nieto continues to believe the price raise is progressive, as it visibly affects the poor, and how jailing so many citizens could be good for the county's economy, as less people go to work.

Mexico's reaction to a raise in gas price is much different than that of the United States. Gasolinazo has not been a headliner in the United States, and many people, when asked, had no idea anything was occurring in Mexico. Yet still, there was the question of how gas prices affect people internationally. Mr. Panish said, "Well the raise of gas prices affects anyone, really, in the same way, as that people have a certain amount of money to

spend on things, and if they have to have gasoline for getting around as opposed to doing mass transit, that's going to affect their spending on other things, and so that's what really affects people no matter where they are." In terms of mass transit, there is a subway, and other limited forms of transit, though some are private, including Uber, which is only available in certain states. Incidentally, part of the Acuerdo is to finally begin to create a stable public transit system, which is supposed to be more accessible and affordable than the current options.

In response to the riots and discontent, President Enrique Peña Nieto made public broadcast talking about why the prices raised, and what gasolinazo means. He talked about the international price of petroleum, and how keeping the old price of gasoline would mean that there would be cuts on social programs, a raise in taxes, and or an increase to Mexico's national debt, which is already exceedingly high. President Peña Nieto, in this broadcast said, "Here I ask you: What would you have done?" Speaking to Mexico, Peña Nieto was implying that there was simply no other option, and that the raise in gas price, as conflicting it has been, is the best route to take.

President Peña Nieto ended the video talking about Mexico's other pending worry, which is the United States's new administration. President Peña Nieto has said that, "Of course not," Mexico will not pay for the Wall that President Trump is imposing. Relations with the United States and gasolinazo are Mexico's two major unresolved issues at the moment, and both hold a great impact on the Mexican people. Mr. Ervin said, "With the new administration coming in... what our trade deal is going to look like, and things like that," when asked about how the rise in gas price will affect the United States, as it ripples internationally.

At home, MASECA, a company that primarily provides tortillas, a staple food of Mexico, has promised to keep their prices the same for the first part of the year. President Peña Nieto said the rise in gas would not affect other things, though it does. Gasolinazo is a continuing feat that Mexico is undertaking, and as prices are expected to rise continuously through the year, the rest is uncertain.

ouglas Adams, author of The Hitchhiker's Guide To The Galaxy, once said, "I love deadlines. I like the whooshing sound they make as they fly by." Sound familiar? You tell yourself you work better under pressure, or that the work you do when you're not in the mood is sub-par. Then the assignment is due and you end up rushing and doing a bad job, leading to sleepless nights, anxiety, and the consumption of large amounts of caffeine, a scenario that sounds all too familiar.

But why do we do this? Moreover, why is it so hard for certain people to stop wasting their time? Tendencies to procrastinate cause these behaviors. We have often been told not to procrastinate on this chore or that assignment by our teachers and parents, so as not to have to suffer from the consequences. But what does this even mean?

Procrastination is the practice of putting off harder and less pleasurable tasks until a later time. Sometimes procrastination takes place as soon as a new task is assigned or needs to be completed, while sometimes it does not set in until the "last minute" before a deadline. More than simply school assignments or chores, procrastination can take hold of any aspect of life, from seeing a doctor to discussing a stressful issue with a partner or friend. It results in feelings of guilt while contributing to a universal sentiment among people that we are wasting our time with useless things.

So how do you know if you're a procrastinator? According to a study by psychologists and psychiatrists in the magazine Psychology Today, most procrastinators have several key indicators: They overestimate the time they have left to perform tasks and in turn underestimate the time it takes to complete those tasks. They overestimate how motivated they will feel the next day, the

ed they will feel the next day, the next week -- or until whenever they are putting things off to.

They think that succeeding at a task necessitates that they "feel like" doing it. They deliberately look for distractions, especially ones that are easily accessible.

Guilty? That's okay, everyone procrastinates to some degree. However, 20% of people persistently avoid difficult tasks and purposely look for distractions—which, unfortunately, have become increasingly available. Some recent surveys suggest that 85-95% of students have problems associated with procrastination with an immense 70% of college students admitting to being procrastinators.

Procrastination has increasingly become a problem for the modern student as the workload and demands on the student have increased in difficulty. However, many students -- unaccustomed to the immense demand of them that comes with taking harder classes and making their own path in life -- do not yet have the skills to manage their time wisely. This results in greater levels of stress and sends stress hormones through the body, wearing it out faster. Moreover, prolonged exposure to stress can considerably damage and erode critical parts of the DNA over time, thereby shortening one's lifespan. It also weakens the immune system as a result of the sleepless nights spent working on assignments and the malnutrition resulting out of a lack of time to prepare necessary nourishments. Even worse, there is a likely delay in seeking treatment for medical problems as everything else has been delayed. Procrastination is not good for your health yet it is "very much the tendency of being a student to procrastinate and it just means that some of the work that is turned in is of lesser quality," English teacher Bonnie Thore-

Sometimes our reasons for completing a task are not sufficient to motivate our action of actually doing the task. Inadequately defined intentions are part of the problem. We are not really in the mood to do the task, but we don't like the tension or dissonance it creates in us, so we declare vague intentions like 'I'll do that later' or 'I'll get to that this week,' making it impossible to control and regulate our actions against such a crudely defined guideline. Furthermore, we do not remove distractions that we know undermine our work. We make up lies while waiting for something to inspire

us or to motivate us to act, all the while knowing deep down that they are nothing but excuses.

We easily become distracted and sometimes are highly impulsive. "It will take me only a minute to update my Facebook page, read that blog.... Oops, it's already night?" In a world influenced increasingly by the economics of attention, we have to be careful where we invest our time. As we sleep away 1/3 of our lives there are only so many minutes in a day, in a year, in a lifetime, to which we can give attention. The whole world is competing for our attention with marketing designed specifically for each of us. It's personal, seductive, and distracting. The media is often seen as an escape from reality. It helps us forget and sedate our troubles and problems. We all need to escape from our responsibilities and daily stresses in order to restore ourselves to full power.

In a similar fashion, we all need to delay things to fulfill our priorities, making procrastination "inevitable as there is just not enough time to do everything. Also it affects [the students'] grades pretty drastically but some of them are pretty skilled in the ways of procrastination," said Junior Sage Metzler. These skilled students have developed their own tricks to keep their stress levels at a minimum and productivity at a maximum. Junior Stella Bloch said "I stress myself out in the moment and I get everything done then so then I don't have to do it later." Similarly, Junior Kendrick Rivard said "stick to a schedule and have people that you can rely on to consistently check on you to make sure that you are getting your stuff done."

The real issue also has more emotional roots. Although we may know intellectually what we should do right now, we do not feel like doing it, so we focus on short-term ways of repairing our mood: We want to feel good now and worry about that task later. Or simply put, short term gain, long term pain.

However, procrastinators are made and not born, which is good news. Good because it is a learned response, and what has been learned can be unlearned, but it takes a lot of emotional and intellectual energy to change. So in order to make life a little easier, here are some tips for all you procrastinators out there:

Start somewhere. One of the most effective solutions is to just start. As soon as you begin thinking 'I'll do this later' or 'I work better under pressure,' acknowledge that you're making excuses. First, stop yourself, then start the task somewhere, such as writing an outline for an essay or sweeping a section of the floor.

Preempt that which tempts. The solution to distraction lies in recognizing what is distracting and then either eliminating the nuisance or declaring an aim to indulge it at a specific time. For example, turn off your distracting phone or other electronic devices and make a promise to use it again later after you have gotten some work done.

Estimate the amount of time it takes to complete a task, then increase that amount by 100%. People tend to be overly optimistic and underestimate the time it will take to complete a job. This makes them feel upset and angered when their underestimated time limit is not met as they had planned to do other things in the meantime, further delaying other assignments. Incorporate the possibility of distractions and mishaps occurring by, for example, changing the time limit to six hours for an essay that supposedly takes only three. Acting in a timely manner on tasks requires actively making choices and recognizing the enemy within, thereby moving forward to doing that which you intended.

Make a list of everything you have to do. Organize tasks by importance. Remember, organization is a key ingredient in completing any lengthy or overly complicated task with as little confusion as possible. Simply move down the list and complete each task one at a time.

Set realistic goals. Don't think too far ahead, just aim for a little progress. By establishing a minimum to a task, your engagement fuels motivation and changes your perception of the task, and you will find a task not as difficult as originally thought to be.

Break the job down into specific tasks. People procrastinate more on unpleasant tasks, that's common knowledge. But, by reducing

the pain of working on a project by breaking it down into more familiar and manageable pieces, it effectively reduces procrastination

Make your task meaningful. Apply some combination of increasing the value of the task and decreasing the influence of the distraction. Because people are motivated to maintain a positive self-image, goals that are connected closely to one's identity take on much more value. Connecting the project to more personal sources of value, such as life goals or basic values can fill the lack of emotional value that underscores procrastination.

Promise yourself a reward. Getting something done is a delayed reward, so it is not valued as much in the present. The further away the deadline is, the less appealing it seems to work on the project right now. One way to increase the value of completing an assignment is to make the finish line seem closer by vividly imagining a future reward.

Eliminate jobs you never plan to do. Let's be honest, doing unnecessary tasks is simply a waste of precious time that could be spent on completing the task faster and on leisure time.

Prepare ahead of time - that might be mental rehearsal, learning new strategies and tactics to deal with difficult people, going on a public speaking course, etc.

Anticipate other people's disagreements and practice responding to hostility so you are ready for it when it comes your way

Use positive assertions about your own strengths

Surround yourself with inspirational people and things

Last but certainly not least, have faith in yourself and the fact that you will ultimately triumph!

Thankfully, a majority of Phife's verses' were already recorded and the new project was almost complete. The album was officially announced on October 27 of last year. Fan's were in disbelief due to the Phife's death but were filled with excitement and anticipation. The album was released November 11 and was met with high praise from fans and critics alike. The album's name We Got It from Here... Thank You 4 Your Service symbolizes the group passing the torch to a new generation of rappers and thanking the all love and support the group was given during their reign over hip hop. # 13th Documentary

ave you seen the documentary by Ava Du-Vernay, 13th? Why not? It's required watching for all Americans should know about the 13th Amendment and the loopholes behind it. 13th is available on Netflix, and was nominated for Best Documentary at the Academy Awards.

The 13th Amendment states, "Neither slavery nor involuntary servitude, except as a punishment for crime whereof the party shall have been duly, convicted shall exist within the United States, or any place subject to their jurisdiction." Anyone sent to prison can still be enslaved.

The U.S. government has locked up the black population over minor incidents in prisons to keep them enslaved for years after slavery was "abolished". Ava DuVernay, director of Oscar nominated Selma, uses footage and images from post civil war to modern day, as well as interviews, to highlight how slavery hasn't fully disappeared in America.

DuVernay makes her argument based on startling statistics, horrific footage and photos of lynchings, fire hosing, police shootings, prison fight footage, prison labor, the war on drugs police brutality, phone calls, civil rights activists, the three strike rule, and images of African Americans getting harassed and abused by Trump supporters.

The film chronicles the rise of the "War on Drugs" in the 1980s and 1990s, which included policies such as the harsher sentences for possession of crack cocaine over powdered cocaine. Possession of crack, which is a cheaper version of powdered cocaine, can carry the same sentence as the possession of the quantity of cocaine that is 100 times larger. This caused an uproar between the poor and the rich, as crack was trafficked more in poor communities and inner cities, while cocaine was used in wealthier areas. The War on Drugs targeted poor and inner-city communities over the wealthy communities.

Thousands of African-Americans were thrown into prison with extensive sentences for small possessions of crack, while the wealthy and white were let off the hook for cocaine possession. The only the difference between the two is that cocaine is a powder and crack is smokeable. During this time, media news, would use the term "super predator" for convicts of drug use. This led to the distrust of the justice system, as the modern justice system is considered the new institution of slavery.

Today, police brutality has caused protests nationally, starting the "Black Lives Matter" movement. This movement began after the shooting of Trayvon Martin, a 17 year old boy who was walking home from the gas station when George Zimmerman shot him because he perceived him as a threat. Thousands of unarmed African Americans have been killed by police, since then causing protests around the country. Also, many films, music, and other art forms are taking a stand in the Black Lives Matter movement, including 13th.

Everyone should watch 13th to learn about the injustices in this country, how they started, how they continue, and then maybe, we can figure out how to improve the future.

# The Name of the Wind: **Book Review**

# Movies Continue to Fail Bechdel Test

having had several successful box office hits such as Deadpool, Zootopia, and Suicide Squad. However, any of these movies fail to include women as central characters, instead choosing to focus on male storylines and characters.

A test developed in 1985 by cartoonist Alison Bechdel criticizes movies and filters them through three simple tests; 1) whether there are two named female characters, 2) whether those characters hold a conversation with each other, and 3) whether that conversation focuses on anything other than men. This test highlights the lack of female influence in media and fiction. Bechdel devised this test after noticing a huge absence of female characters in the media, but she largely attributes the idea for the test to her friend Liz Wallace, and further back to Virginia Woolf, who mentioned the absence of useful female characters in her books. The test brings light to the spotlighting of male characters in popular fiction and shows the staggering absence of useful female characters that revolve around anything other than men. A study conducted in 2015 filtered all the popular movies released from January to December and found that 45% of those movies failed to pass the Bechdel test. That means that almost half of all of the biggest movies released in 2015 failed to either portray more than one named female character, failed to have those characters speak to one another, failed to

have them speak about something other than men, or failed all three criterias. Fifty Shades of Grey passed the test, but other movies like Mission Impossible: Rogue Nation failed all three questions. The Hobbit: An Unexpected Journey doesn't even pass the first criteria, failing to have more than one named female characters. These statistics seem to be influenced by whether the team writing the script for the movie are comprised of all male workers or not. Roughly 50% of movies written by an all male team from 1995-2005 fail the Bechdel test, while only 6% of movies written by an all female team fail the test. This creates a problem, as about 85% of filmmakers are men.

Junior Sierra Todt says she is "appalled by the lack of women in movies", and is "offended moviemakers don't make females a bigger priority." However, the Bechdel test isn't always the best filter for popular movies. Tumblr user Chalia devised a new test, also with three questions, in which for a movie to pass the test it must have a) at least one female character; b) who gets her own narrative arc; c) that is not about supporting a man's story. This test is centred around portrayals of feminism in movies, not just the broader generalization of women's conversation. Statistics have not been gathered on this test, though, as it was only introduced recently.

Both these tests highlight the obvious lack of feminine portrayal in movies, a problem that has not evolved, but will hopefully continue to gain notoriety and be addressed.




# **Blonde** Frank Ocean

Further north in Oakland, 11 were arrested after the windows of shops were shattered and illegal fireworks were set off in the streets. These protests are not exclusive to the west coast, as ral- that he would like to repeal the be affected by our new president. jor cities such as Philadelphia and Minneapolis had road closures to guarantee protesters' safety.

Colleges, high schools, and middle schools also expressed their displeasure by staging walkouts in the middle of classes. Local colleges such as UCLA and USC saw mass outcomes as demonstrators left their classes in favor of walking down the streets of LA chanting sayings such as "not our president." In Menlo Park, California, the seniors of Menlo-Atherton High School left their school in the middle of 3rd period causing road blockages throughout the area.

On Nov. 12, a protest in Los Angeles spanned a total of 6 miles. When asked why they were attending the protest, most expressed their concern for their rights. President-elect Trump says women's rights, and restrict immigration to America. Many are scared of what this may mean for them, their families and others of the same race, gender, or sexual preference.

"I'm scared that I won't be able to control my own body anymore, which should be a right to everyone," said college sophomore Bianca Foster. # **Trump Plays Politics** with Women's Health Around the World

n Jan. 23, the Trump administration reinstated the Mexico City Policy, also known as the "Global Gag Rule," to cut all federal funding for NGOs worldwide that "counsel people on family planning options that may include abortion." The policy was first introduced in 1984 by Reagan, and has been revoked and then reinstated by every Democrat and Republican in the Oval Office since.

According to the Guttmacher Institute, the United States spends over \$600 million a year in foreign assistance for family planning, which allows about 27 million women and couples worldwide to receive contraceptive supplies and services. This money, instead of increasing the number of abortions, actually averts 2.3 million abortions per year, with about 2 million of them typically being unsafe, and preventing 11,000 maternal deaths.

White House Press Secretary Sean Spicer said, "I think the reinstatement of this policy is

not just something that echoes that value, but respects taxpayer funding as well, and ensures that we're standing up not just for life of the unborn, but also for taxpayer funds that are being spent overseas to perform an action that is contrary to the values of this president."

However, the Helms Amendment, passed in 1973 following the decision made in Roe V. Wade, already prevents the use of US federal aid for abortions. The Mexico City Policy instead cuts funding for any organizations that even discusses abortion with women, even if they provide many other health services, such as birth control or sexual educa-

History has shown that abortions are never prevented by making them illegal, getting rid of clinics, or cutting funding to health providers that may provide them. In collaboration with the World Health Organization, a Stanford University study found that after George W. Bush reinstated the Mexico City Policy in 2001, abortion rates in sub-Saharan African countries increased instead of decreasing.

The cutting of funding to health organizations will create 2.1 million unsafe abortions and 21,700 maternal deaths in Trump's first term, according to Marie Stopes International, a global family planning organization that works in 37 countries.

The Mexico City Policy also hinders prevention of HIV and AIDS in developing nations, as frequently the only organizations that provide condoms in certain nations were defunded, as was the case with Planned Parenthood in Lesotho in 2001.

President Trump signed the Mexico City Policy on Jan. 23, surrounded by cabinet members and staff, including Vice President Mike Pence, White House Chief of Staff Reince Priebus, Senior Advisor Jared Kushner, and Chief Strategist Steve Bannon. Although the policy being signed primarly impacts the lives of women of color in developing countries, the signing was attended mainly by white men, showing how such important issues in society are decided by those they affect the least.

# Measure H: Addressing Homelessness in LA

n Mar. 7, voters in Los Angeles will be casting ballots in a special county election on Measure H. a ballot measure designed to address the increasing amount of homeless citizens in the county. If implemented, Measure H is expected to get nearly 45,000 citizens off the streets, while preventing a further 30,000 from losing their homes in the first place. The funds for the relief programs will be raised through a one-quarter of a cent increase in the county's sales tax, which will remain in place for 10 years.

The increase in the sales tax is expected to raise \$355 million, with the money being invested into educating, rehabilitating, and resituating the homeless. This money would be supervised by a five member Citizens' Oversight Advisory Board, which would be responsible for reviewing the distribution of funds twice a year. The money raised from the tax would be placed in a special account, and solely allocated to homelessness relief and preven-

Although the measure will raise the sales tax in Los Angeles County, the aggregate tax rate would not surpass the tax limit established by prior ballots. However, opponents of the bill contend that the funds raised by Measure H will be distributed to the same institutions which, in the past, have failed to effectively confront the homelessness crisis. Others object with regard to the fact that there are already enough funds available to confront the homelessness crisis but that these funds have been spent ineffec-

Regardless of their support for measure H, communities and citizens have reached a general consensus that Los Angeles is experiencing a severe homelessness crisis. In January, 2016, there were an estimated 47.000 homeless people within the county, with tens of thousands of others at risk of soon becoming homeless. This figure shows a 19% increase in the homeless population from 2013, a number that shows no signs of declining.

If Measure H does not receive more than 66% of the vote it will not pass. Whether you support the Measure or not, the Current actively encourages its readers to make their voices heard and cast their ballots on Mar. 7. The location of your nearest polling stations can be found online.

# Trump's Immigration Executive Order

n Jan. 27, 2017, President Donald J. Trump issued an executive order restricting immigration from seven terrorist prone countries, taking the nation by surprise. It has been a key campaign message of Trump to suspend immigration from countries that pose a threat to America's National Security. The countries that are affected by the ban are Iraq, Iran, Syria, Somalia, Sudan, Libya, and Yemen for 90

In Section 1 of the executive order it briefly states that deteriorating countries that suffer from strife increase the likeliness that terrorists from these countries will use any means necessary to enter the United States. Not only does the order speak out against terrorists or any ties to terrorists, but also mandates that the United States needs to be vigilant in implementing a visa-issuance process that also screens Islamists, Jihadists, or anyone that places their own ideology before the American Law and is not willing to uphold to the Constitution.

Section 2 briefly states that it is the policy of the United States to protect the citizens of the country. Section 3 explains that the U.S. should suspend all issuance of vi-

sas in the countries of concern. It also stated that the Secretary of Homeland Security will consult with the Secretary of State to review the information the country needs to safely ensure that the visa issuance program can properly screen people that have any intention of harming the United States. In order to reduce investigative burdens on agencies during the review period, section 3, subsection c officially states that immigration from the seven countries of concern will be temporarily suspended for 90 days to ensure that the reviewing period is smooth and effective. This statement excludes those who travel on diplomatic visas, North Atlantic Treaty Organization visas, C-2 visas for travel to the United Nations, and G-1, G-2, G-3, and G-4 visa). The remainder of Section 3 suggests that the Secretary of State and Secretary of Homeland Security will brief the President if there are any other countries that deserve the same treatment. On the other hand, if there is a specific situation where it is in the nation's interest and benefit to issue visas to any of the countries that have been blocked, the United States will do so. The Secretary of State will give a report every 30 days on any progress.

Section 4 issues that the Secretary of State, Secretary of Homeland Security, Director of National Intelligence, and the Federal Bureau of Investigation will develop a screening program that successfully detects people that will potentially harm the United States. This includes uniform screening with personal interviews, the ability to ensure that fraudulent documents that are used by multiple applicants are detected, forming questions based on whether the applicant will cause harm to the U.S., a mechanism to ensure that the applicant is he or she claims to be, and a process to detect whether or not the applicant will be a positive contributor to society.

Section 5 deals with the Refugees Admission Program and that it will suspend the USRAP for 120 days. During this time, the order says that the Secretary of State and Director of National Intelligence will review the US-RAP to decide if there needs to be a change in the application process for admitting refugees into the United States. In subsection B, it states that to the extent permitted by the law, the U.S. would prioritize in letting in refugees that are religiously persecuted and are a religious minority in their country. This section hereby announces its claim to deny all syrian refugees and the entry of 50,000 refugees in the fiscal year of 2017. Subsection (e) states that it will allow refugees in even from the seven listed countries if it is proven that it is in the Nation's interest and will not burden the welfare or security state.

Section 7 calls for the completion and implementation of the Biometric Entry-Exit Tracking System which is recommended by the National Commission on Terrorist Attacks Upon the United

Section 8 calls for the retraction of the Visa Interview Waiver Program and instead have all individuals seeking a nonimmigrant visa be required to undergo an inperson interview.

Section 9 orders that the Secretary of State shall review all nonimmigrant visa reciprocity agreements to ensure that they are truly practicable with respect to their validity period and fees.

Section 10 calls for the transparency of policies used for data collection.

Section 11 finishes off the order with the statement that the order is not intended to affect the authority granted by law to an executive department or agency or affect the Director of the Office Management and Budgetary.


The legality of the ban has raised some questions to the public but under Title 8, Chapter 12, Subchapter 2, Section 1182 of U.S.

law, it quotes "Whenever the President finds that the entry of any aliens or of any class of aliens into the United States would be detrimental to the interests of the United States, he may by proclamation, and for such period, he shall deem necessary, suspend the entry of all aliens or any class of aliens as immigrants or nonimmigrants, or impose on the entry of aliens any restriction he may deem to be appropriate." According to U.S. law, the ban should be legal when reviewed under these terms, however, the Department of Homeland Security has temporarily halted the enforcement of the law and has ordered border security to return to procedural checks of immigrants entering the United States. The halt on the ban was implemented by the 9th Circuit Court of Appeals and they will not determine whether the ban remains constitutional but whether the halt remains in action. Whether or not the ban will be successfully and legally implemented will be determined by the Supreme Court. This fact may slow down the confirmation of Trump's Supreme Court Justice appointee, Neil Gorsuch. Trump also has the option to re write the order completely or he has the option to challenge the 9th Circuit.












Sexually Active Students: Was Your School Provided Sex Ed Adequate?



# Should Tampons & Pads Be Free?

n average, a woman will spend a combined \$3,500 on tampons and pads during her lifetime, depending on lengths of periods and preference on what to use. The cost of most things for women is typically more than what a man would pay for the same product, and while there is no male counterpart for tampons or pads, the products are still taxed and highly priced. The average box of tampons costs about eight dollars and the average price for a box of pads is around seven dollars. As a girl who gets her period, I find it unfair that I spend around nine dollars every one to two months for something that I cannot control. While there are people who choose to protest the price of pads and tampons by simply not using them and rather using "period panties", I personally am opposed to this based on comfort. I find pads and tampons are the easiest choice for most women. The price of sanitary products is a burden for women who are homeless or cannot afford them due to financial hardships, but pads and tampons cannot be bought on food stamps.

I believe that pads and tampons should be free because the menstrual cycle is a biological function that women cannot control. Junior Bonnie Higginbotham says, "Of course I believe they should be free, a period is not something I as a woman can help. Sorry." This idea is shared globally, as more and more women are starting to grow tired of the high prices they have to pay about 12 times a year. Junior Axel Romero says "Tampons and pads should be free. They are a basic necessity, and it is inhumane that they are not." Tampons and pads are necessary for women and not something that women should have to pay for.

Worldwide, women are paying increasingly expensive prices for tampons and pads, including sales tax. Tampons and pads are heavily taxed in the U.S, including California, which taxes about \$3. With the exception of the 10 states that do not tax tampons at all or have no sales tax on them, women in the other 40 states are being taxed for having a basic biological function.

Over the summer in 2015 after an online petition gained traction, Canada lifted the tax on feminine hygiene products completely, showing that the federal government can get involved to make the prices more reasonable for the average woman. It makes sense that the government should supply free products to women because they are a necessity. Romero says "It would be difficult to get the government to pay for them, but it should be the government's responsibility. It's a medical necessity." It is true that it would be difficult to get the government to pay for tampons, especially because menstruation is a taboo in many cultures.

With Trump's administration's conservative agenda, I do not see pads and tampons becoming free in the near future, although it could be determined by state government. Higginbotham adds that "The government should pay for tampons, because they are so expensive and there are women on the streets who cannot afford to pay for them, and if you have a period it is a nightmare to not have any supplies." Women who live on the street or are struggling financially have no access to pads and tampons. Women on food stamp programs cannot buy pads and tampons with them, as they are not considered an "absolute need". Women who are homeless have to resort to using rags or toilet paper from public restrooms to make makeshift pads in order to get through their period.

Junior Zara Schucester says "There should be lady toiletry stamps, to allow women to be sanitary and comfortable." Since the government has done nothing to help, small independent organizations, such as Distributing Dignity, are starting to offer free supplies to those in need. However, the reality of getting pads and tampons to be completely free is not very plausible because of the large amount of support it would take to have free products. One possible idea is to tax people extra to be able to pay for the free distribution of pads and tampons, Romero to which adds he "Would be completely fine paying more taxes to make tampons free, as they've become excessively expensive."

However, getting people on board with raising taxes to pay for feminine products would be a struggle, especially with a large portion of the population already concerned with the current tax rate. Instead, eliminating the tax on tampons would be more plausible and just as helpful. A big step, especially in the United States, would be to remove all taxes on tampons and pads, which has already happened in a few states. There should also be free tampons in public restrooms, not only for those who get their period with no supplies on hand, but just to make them more accessible for those who cannot afford them. I would also like to see a greater effort to ensure that homeless women and those who cannot afford tampons can get free supplies. Hopefully in the years to come women will not have to pay as much for pads and tampons just because of a normal bodily function.

hile most of us aren't necessarwaiting for the Sunday paper to know what's going on in our world, the newspaper is still a significant source of current events and local stories that keeps people updated and informed. Readers are usually focused on what the newspaper puts out, trusting that those behind the scenes are doing their best to deliver us honest, relevant news. However, what's happening behind the scenes at the LA Times has ironically become front page news. Editor-in-chief Davan Maharaj has been deemed 'what's wrong with the LA Times' as he allegedly is running the paper into the ground. Applications for a job at the Times have been unavailable for two years now and the paper has lost a number of its most respected employees of Glover as it pleaded guilty to people are not quitting the *Times*, with breaking news, Senior **De**-during that time. with breaking news, Senior **De**-they're quitting to leave their **clan Sheridan** said "Of course. I

The public's first glimpse at the paper's internal struggle was revealed with the publication of Maharaj's refusal to pass a story proposed by one of LA Times' 'most talented investigative journalists', Scott Glover. Glover and his longtime partner Matt Lait set out to research the nation's drug epidemic, and released several stories on rogue physicians writing painkiller prescriptions for cash, grabbing the attention of the Times' readers. In 2010, Glover teamed up with veteran Times' healthcare writer Lisa Girion pursuing the investigation on the link between these rogue physicians and opioid-related deaths, with the final product being published in 2012 under the title "Dying for Relief". In 2013, Purdue Pharmaceuticals, a leading OxyContin maker, caught the attention

fraudulent marketing practices. Glover and others spent hours analyzing leaked memos, e-mails, and court documents of Purdue, piecing together a remarkable pattern of wrongdoing in Purdue's past. The final product was sent to Times' editor-in-chief Davan Maharaj, who inexplicably delayed the article for more than 15 months, disregarding some of the Time's most valued writers, driving them to quit out of frustration. Glover moved on to CNN, later stating that Maharaj has done nothing in the Time's best interests and uses his power to delay numerous stories that would only be beneficial to the LA Times and its readers.

Glover's story is unfortunately not a unique case, the *Times'* newsroom is now a third of the size it was 16 years ago. A member of the Paper's staff says "these

boss". A majority of the Times' ex-staffers have been given severance payouts in exchange for their signature on a nondisclosure agreement, making them contractually prohibited from voicing anything negative about Maharaj. Following the recent breakout on the topic of 'Fake News', the condition of the LA Times raises a new concern for the public: are our newspapers still trustworthy? How do we know that the people working behind our nation's news sources are to be trusted with keeping us up to date with all that they can. A story on OxyContin isn't necessarily breaking news, but it certainly makes you wonder what other stories have been held back by power hungry leaders. When asked whether or not he trusted that the newspaper was doing all it could to provide us

trust the newspaper because they have actual sources and a good reputation. It's also been around forever". When I asked Declan whether or not he'd feel deprived if the newspaper was no longer a source of news, he said, "I get most of my news from CNN because I know I can trust it, so I wouldn't really be affected if the LA Times was discontinued, but I'd feel betrayed if it was keeping things from it's readers. t is rare that the film chosen as Best Picture by the Academy of Motion Picture Arts and Sciences is truly the best film made that year. Although we dare to dream that films are chosen on their merits, it is more truthful to say they are chosen through a combination of their ubiquity, marketing campaigns, and some unknowable forces in the zeitgeist. This year was different.

A true Best Picture film requires two absolute traits - near perfect execution of filmmaking and transcending the medium. That transcendence can come in many forms - style, content, pure filmmaking feats of magic, etc. Titanic (1997) meets these criteria for its incredible representation of a sinking ocean liner, Gladiator (2000) for its near perfect filmmaking (the melding of screenwriting, acting and directing into a flawless film), Lord of the Rings: Return of the King (2003) for the unmatchable trilogy that brought a beloved canon in western civilization to the screen in a way that is still unmatched by any other director. These films rise above mere moviemaking to demand that we understand and

feel something more than we did before we stepped into the movie theatre. I now know how it might have felt to stand on the Titanic as it sank into the freezing abyss. Best Picture Oscars should go to films that break new ground.

On the flip side of this are films that won Best Picture and clearly have not stood the test of time. When was the last time anyone watched Chicago (2002)? How about Crash in 2005? That won purely because Hollywood loves to believe it is self-reflective about its racism (fun fact: it's not). Or The Artist (2011). It was a wonderful little film, but it won the Oscar because the Academy loves looking back on its heyday in a fog of nostalgia - LA's own version of "Make Hollywood Great Again." In fact, in the last 5 years, films about acting or filmmaking have won 3 out of the 5 Oscar statues (The Artist, Argo and Birdman). All 3 are fun to watch, but are they in the same category as Lawrence of Arabia, Casablanca, or The Godfather? Not even close.

Inevitably this year the question on people's minds was Damien Chazelle's *La La Land* or Barry Jenkins' *Moonlight*? Both are well crafted films made by directors at the top of their game (Chazelle's *Whip*-

lash was my favorite film of 2014). Both are smaller films (costing between 5 and 30 million) that captured a moment in the national collective consciousness. And both speak to the two things that Hollywood does best, escapism and realism, respectively. Yet I would argue that it is only Moonlight that actually transcends its genre. Although La La Land is a fabulous film, it is ultimately a throwback to earlier movies, and it doesn't bring anything new to them nor does it do it as well as they did. Go watch Singin' in the Rain and Top Hat to see what I mean.

Moonlight tells its hard tale with silence, through lush saturated cinematography, evoking time and place. It deconstructs a young life fraught with addiction, violence, and homophobia. Yet none of these themes are presented in the usual way. There are no diatribes against the institutions that created them. No raw images of the devastation of incarceration. No long pronouncements on the wreckage addiction brings. In fact, it's the absence of the usual tropes that makes Moonlight so unique.

It's a quiet, beautiful study of life, giving us a glimpse into the emotional world of a gay, black boy during the 80's crack

epidemic. Even the ubiquitous drug dealer does not get the same treatment here. For once, the black community can tell its story without it being a metaphor. One boy does not need to stand in for the entire black experience. It does not need to tread with reverence on the story of Chiron because *Moonlight* is a film about a boy growing up in present-day America. Who is also black. It does not preach. It does not make him reverential in his fight. He is able to be a part of the fabric of experiences in this country, for maybe the first time. A story about a boy/man trying to find who he is. And his blackness is part of who he is. And so is his sexuality. Moonlight asks the seemingly innocent question, "I'm just trying to find out who you are, little man?" And throughout the remainder of the film, Chiron tries to answer that question for himself. Moonlight makes us feel and understand Chiron's life in a way we never could have without sitting in that theatre. This is what we ask of our storytellers, we do not just want to be entertained, we yearn to be moved.

alibu finally has a burger place! Situated on the upper level of the Lumberyard, Burgerfi opened after months of anticipation (mostly mine) last week. Because of previously stated anticipation, I had to check it out for myself. And I am the first one to admit, I might have went a little overboard on the amount of food I ate, especially considering I was with a gluten-free friend who couldn't eat a single thing on the menu. Anyways, despite my selfishness fueled by my ravenous hunger, I ordered the CEO, a double wagyu brisket blend burger with homemade candied bacon-tomato jam, truffle aioli, and aged Swiss. I also got a red velvet milkshake and fries.

First, let's talk about the burger. The first few bites were quite a rollercoaster; the truffle flavor gets the mouth watering, which is quickly combatted by the sweetness of the bread. This might be an entirely boring way to characterize a burger, but in the end the bread was the best part. It was sweet and fluffy and most

n 1922, Hermann Hesse wrote the following: "Wisdom cannot be imparted. Wisdom that a wise man attempts to impart always sounds like foolishness to someone else... Knowledge can be communicated, but not wisdom. One can find it, live it, do wonders through it, but one cannot communicate and teach it." In this brand new series, "Fireside Chat with Evensen," featuring Thor Evensen, it will be helpful to meditate on Hesse's words, almost as a mantra. While Evensen can put forth words of his own knowledge and experience, some of which you may agree with and some you may not, he cannot give you his knowledge and experience, as perhaps acknowledging our limitations is the only way to truly surpass them.

Now, I will ask you, the reader, to suspend your disbelief and let your mind wander to a place of safety, warmth, and security. Consider a small, protected log cabin snuggled firmly between an old pine tree and a gentle flowing river. You are freshly bathed, reclined in a plaid armchair, wearing a soft bathrobe, reading a nice book as you notice an occasional crackle coming from the fireplace. As you begin to go in for another sip of your favorite warm beverage, you hear a quiet knock at the door, one that does not startle you, as it is deeply familiar. You mark your place in your book, put down your cup, sit up straight, releasing a low, much needed grunt, as you slide your warmed feet into your slippers, and walk towards the door. You reach for the handle and slowly pull open the door, revealing, the only person it could have been, Thor Evensen, wearing a calm and knowing face.

Evensen and I cozied on down atop two stools, heated warmly by a distant fire seen only in one's mind, to chat about one of the central issues of our time: distractions away from the truth through the institutionalized manipulation of information.

Evensen: The "theory of misinformation" is that we get our information from turning on the TV, you listen to these news people and you read the paper or magazine, but is the information correct? Or is it misinformation? Let's take for example this election. Everyone was talking about Trump and Clinton and Trump and Clinton, that was all the information we were getting. But was there other information that they were leaving out and not giving us? More important issues like poverty, equal rights, justice, and other real social issues that affect millions of people.

Evensen claims that the media spent, and continues to spend, too much time focusing on shallow, day-to-day stories, while neglecting the more critical issues; this is not unfounded. A recent study was conducted to find the top receivers of media attention during the 2015-2016 primary season. Hillary Clinton received \$746 million in free advertising, coming in second on the list, Taylor Swift landed just shy of \$500 million, Kim Kardashian and Kanye West cumulatively reached \$450 million, Senator Bernie Sanders received \$300 million, and Donald Trump topped the list receiving over \$2 billion worth of media attention. Bernie Sanders, amidst running one of the most successful and historic campaigns in American history, received less attention from the media than the West family.

Evensen: People are always complaining that there is no money for this, or no money for that, but you never hear this in the media, ever: "we spend this much money on these battleships, and we spend all this money on the military." If we stopped spending so much on the military we would have all of this extra money and we could pay our teachers more and fix up our schools. But if you bring that up they're probably gonna say, "well if you take away our military then other countries are gonna attack us and then we'll be destroyed and it's all because you guys wanted to have better schools." So, if you want to go really deep with this, it's the military. The military takes all of the money, and everyone is complaining that there is no money, but no one ever talks about the reason that there is no money. It's because all of the money is being spent on the military, when we don't really need that much money to be spent on the military. We could not spend money on the military for just one year and give that money to the schools, and we'll see how much better the schools get in just that one year.

In 2015, the United States Defense Budget, the amount of money spent on our military, was \$609 billion. If you were to rank all of the countries in the world according to their military spending the United States is way, way at the top. How high at the top? The United States military budget is equivalent to the entire military budget of China, Saudi Arabia, the United Kingdom, Russia, Japan, India, Germany, France, Italy, South Korea, Brazil, Australia, Turkey, Israel, Colombia, and Spain combined, with a few billion dollars left over. The very same United States has the highest childhood poverty rate of any industrialized nation, the highest rate of incarceration in the world, there is \$1.3 trillion owed in student debt, it has the highest wealth inequality of any major country, and it continues to spend hundreds of billions of dollars on its military every year.

Evensen: People have got to realize that the more we do, the more change happens, and the less we do, the less change happens. If we let them give us misinformation then we're gonna keep spiraling down into this pit of injustice and inequality.

It is important, I believe, for us to take responsibility in the way that we receive information, how we use that information to challenge our own beliefs, and ultimately, how we translate that into the way we treat others, particularly ones with stories much different than your own. Our generation will be running the world sooner than we think, and we owe it to the future generations to not grow up like some of the egotistical, greedy, violent, and heartless people we see in charge today. While this will be a shared goal, each one of us will set out to achieve it in very different ways. I enjoy writing, so I write these articles, Evensen enjoys speaking, so he speaks his mind every chance he gets, what is it that you enjoy? If life is an ocean, and you are a ship, let your passions be the sails and your imagination the winds, and in stormy seas let's all remember; tomorrow could be beautiful.

hat is MMA? A quick rundown of the 'Fastest Growing Sport'

Recently, Mixed Martial Arts, or MMA, has become the fastest growing sports in the world. MMA is a sport, similar to boxing and wrestling, where opponents fight using techniques from a variety of martials arts and combat sports, including both striking and grappling techniques.

MMA originated as a sport when it was brought from Brazil to the United States by the Gracie family. Members of the Gracie family, all masters of Brazilian Jiu-Jitsu, offered the 'Gracie Challenge' to other martial artists. The challenge was an open invitation to fight in a vale tudo match (Portuguese for 'anything goes') an unarmed full-contact sport with few rules. This led to the creation of the Ultimate Fighting Championship, the UFC, in 1993. The first UFC event, now called UFC 1, was "supposed to be a one-off," said today's UFC president Dana White in an interview with How Stuff Works. "It did so well on pay-per-view they decided to do another, and another. Never in a million years did these guys think they were creating a sport.'

Initially, the UFC did not resemble the organization it is today. Fights were unstructured and matches were unorganized. While at its beginning, the UFC used the tagline "There are no rules!," it did, in fact, operate with limited rules to protect the fighters. However, many dirty and cheap techniques, such as headbutting and hairpulling, were allowed under the initial rules. The sport's violent nature drew the attention of U.S. Senator John McCain (R-AZ), who led the campaign to ban the UFC. As a result, 36 states banned vale tudo fighting. In response, the UFC redesigned its rules to rebrand itself as a sport while still maintaining the core elements of striking and grappling. Becoming safer and more structured, the UFC became a proper sport, with weight classes added in UFC 12 and five-minute rounds in UFC 21. Additionally, gloves became mandatory in UFC 14, while hairpulling was removed in UFC 15. This reform in rules led to a surge in popularity for the UFC, becoming the fastest growing sport in the world.

At the competition level, fighters were divided into 10 weight classes: Strawweight, up to 115 lbs; Flyweight, up to 125 lbs; Bantamweight, up to 135 lbs;

Featherweight, up to 145 lbs; Lightweight, up to 155 lbs; Welterweight, up to 170 lbs; Middleweight, up to 185 lbs; Light Heavyweight, up to 205 lbs; Heavyweight, up to 265 lbs; and Super Heavyweight, anything above 265 lbs. While a fighter is allowed to fight up in class, for example a fighter from Featherweight fighting in Welterweight, a fighter can not fight down without losing weight.

Regular fights are organized into a maximum of three five-minute rounds, while Championship title fights and 'main event' fights are a maximum of five five-minute rounds. Between rounds, fighters receive a one-minute rest period. Additionally, UFC fights are staged inside an eight-sided enclosure, 'The Octagon', to separate the fighters from the audience. For attire, competitors must fight shirtless (except in the women's division), shoeless, and wear shorts. The gloves used by fighters are lightweight and open-fingered, allowing for grap-pling and striking. The gloves must have at least one inch of padding around the knuckle. This is done to prevent injury to hands, which are commonly broken in bare knuckle boxing. Finally, fights are judged by three judges

who decided the outcome in case a fight finishes without a winner.

A fight can be won in a variety of ways. Matches may end in submission, in which a fighter 'tapsout,' verbally submits, or loses consciousness. Knockouts occur when a fighter is knocked unconscious during the fight, while a technical knockout occurs if the referee decides the fighter can not continue. Technical knockouts can either be called by the referee, a ring-side doctor, or the fighter's own corner man. Judges' decisions occur when a all the rounds have ended and there is no clear winner. The most common judge decisions are either unanimous decisions, all the judges score a fight for the same fighter, or split decision, where two judges score for one fighter and one judge scores for the other. Lastly, a fight can be decided due to disqualification, in which one fighter is disqualified and the other is deemed the winner; forfeit, in which a fighter ends the fight early; or no contest, an outcome reserved for unforeseen circumstances.

Training for MMA requires both learning a variety of martial arts techniques as well as training one's body. The most common martial arts utilized in MMA are Brazilian Jiu-Jitsu, Muay Thai, Judo, and kickboxing. Sage Metzler, a Malibu High Junior, said, "MMA' means mixed-martial arts, it does not specify a specific fighting style. At my school, we practice several different styles that all work together."

Junior Frankie Churchill, who has trained in MMA, said, "I've played a lot of sports, but MMA is something special. It has the best competition feeling."

MMA is about more than just fighting, for many practitioners fighting is about discipline. Sage Metzler said, "A focused atmosphere is essential for training, and that can only be achieved through discipline. The discipline we establish can be transferred and applied to all aspects of life." But fighting at the competitive level has its risks. Many fighters have suffered from concussions and long-term brain damage. Muhammad Ali was diagnosed with Parkinson's disease due to being hit in the head during his long ca-

Even with these risks, MMA is growing rapidly as a sport, with the potential to overtake other popular sports as a worldwide phenomenon.

# Super Bowl LI

n Sunday, Feb. 5, 2017, the fifty-first Super Bowl took place in Houston, Texas. The two teams competing for the championship were the Atlanta Falcons, and the New England Patriots.

Both Atlanta and New England were well qualified to go against each other in this last Super Bowl. In 2016 the Atlanta Falcons placed first in the NFC of the South, whereas the New England Patriots placed first in the AFC East. Attempting to convey unity in the midst of the current political divide in the country, dots of red and blue in the sky transformed into the flag of the United States. Gaga then fell through the stadium roof to make her en-

trance, flipping in the air until she made her way onto the stage. The performance consisted of a lot of visuals, and Gaga used the entire stage and an audience to make her performance. She effectively incorporated many of her most popular songs such as "Just Dance", "Bad Romance", and "Born This Way." The overall performance has been regarded as very entertaining, and one of the best.

In the first down of the third quarter the Falcons had the ball. where Ryan passed it to #24, Devonta Freeman. The play reached the fourth down and went to New England, and at the third down there was a kick. which was received by one of the Falcons. Brady continued having issues as his teammates would fail to sometimes even come near the ball he had thrown, making it difficult for the team to advance anywhere. The Falcons then received the ball, and at the third down there were two flags on the Patriots. The Falcons then made it to first and goal, and the play unfolded beautifully as Ryan passed the ball to #26, Tevin Coleman, who made the touchdown. With the field goal, Atlanta had a leading score of 28 to 3. New England proceeded to make their play, and at a third and eight, Tom Brady ran with the ball. Eventually the Patriots made it to first and goal, followed by second and goal, which was then the winning play for a Patriot touchdown, raising the score by 6, the field goal being missed. The end of the third ended with the score of New England 9 and Atlanta 28.

The fourth quarter began with the ball in the Patriot's hands with the fourth down at 25 yards to go. The Patriots successfully received the ball, and fell through 3 more first downs until they made it to first and goal, where Tom Brady was thrown down by #97 of the Falcons, Grady Jarrett, leading to a second down and goal for the New England Patriots. Brady threw the ball to #28,

James White, who could not successfully get the ball safely to the goal, so the Patriots attempted a field goal, which brought them to 12 points. The Falcons then had the ball and were advancing when a fumble was called, giving the ball to the New England Patriots. The Patriots ran to a second down with three yards to go when #80, Danny Amendola, made a touchdown, bringing New England's score to 18, and then 20. The Atlanta Falcons started their first down with Quarterback Matt Ryan passing the ball to Freeman #24, making it to 50 yards on the field. The Falcons continued to progress as they continued to get closer to the goal, though they were not able to successfully complete another touchdown.

In fact, the Atlanta Falcons were not able to score again, and their score remained at 28. The Patriots continued to fight even at time 3:30, Brady's first catches being incomplete and then received, until the team made it to time 1:40, at first and goal. At the second down and goal, James White made a touchdown for the Patriots, bringing them to a score of 26, only two points behind the Falcons. The Patriots proceeded with a two-point conversion, tying the score 28 to 28. Atlanta's #33, Blidi Wreh-Wilson, ran and fell harshly against the ground leaving no change to the score, forcing the game to pass into overtime, which had never before happened in Super Bowl history. With another coin toss, the New England Patriots started with the ball. After several fumbles the Patriots made the touchdown, winning the Super Bowl LI.

This year's Super Bowl was quite exciting as the entire game turned in the fourth quarter, and the winning probability for the Patriots droped to 1%. Tom Brady is now the first quarterback to ever win five Super Bowls, in a game that was the first Super Bowl to go overtime.

n the first half of their 2016-17 NBA season, the Los Angeles Clippers have posted a winning record of 24-16. The Clippers are in fourth place in the Western Conference behind of the Rockets, Spurs and Warriors. This the is the Clippers 47th season as a franchise in the NBA, their 39th season in Southern California, and their 33rd season in Los Angeles. This year, the Clippers are managed by Doc Rivers who has put together one of the best starting lineups in the NBA. This line up includes Blake Griffin as their power forward, DeAndre Jordan as their center, Chris Paul as their point guard, J.J. Redick as their shooting guard and Luc Mbah a Moute as their small forward. Backing up for Luc Mbah a Moute is two-time all star forward Paul Pierce, and Jamal Crawford is next in line after J.J. Redick for shooting guard.

To start the season on, the Clippers played the Trailblazers in Portland. Throughout the duration of the game, the score remained close, but at the end, the Clippers won their season opener defeating the Trailblazers 114-106 on Blake Griffin's 13 rebounds and Chris Paul's five assists. The Clippers beat the Jazz and the Suns in the next two games, but the Thunder snapped their three-game winning streak by beating the Clippers in a close game with the final score being 85-83. The highlights from the game were Russell Westbrook with 35 points and Chris Paul

with 9 assists. After their loss to the Thunder, the Clippers stepped it up and won their next seven games scoring over 100 points in six of them.

The Clippers second loss of the season was against the Memphis Grizzles, with a final score of 111-107. The Clippers still played a great game with DeAndre Jordan coming out with an impressive 21 rebounds in the game. The Clippers continued to put up good numbers while winning their next four games. The Clippers were on a roll until December 23, when they played a home game against the Dallas Mavericks. They lost the game 90-88, and unfortunately, that game started a 6 game loosing streak where the Clippers seemed to lose some of their offensive intensity. This streak snapped on January 2nd at home against the Phoenix Suns. The game ended with the Clippers winning 109-98 on Redick's 22 points and Jordan's 20 rebounds. After that win, the Clippers went on to win the next 3 of their games against the Grizzlies, Kings, and Heat.

The Clippers, along with many other NBA teams have never won a title, but this year might be different for them. "The Clippers won't need to wait long for a chance at redemption from last year's postseason" NBA Digital Content Coodinator Rowan Kavner said, and with the way they are currently playing, they are on the way to the playoffs and potentially the finals.
